- IV. Treasurer's Report

- V. Old Business
 - A. Block party update
 - 1. The block party was tentatively planned for August, but a decision was made to delay the party in order to save funds and gain information from homeowners on the format and timing.
 - 2. We will survey the neighborhood to gauge interest, ask about the format, and determine the best time of year for a party.

VI. New Business

A. Mosquitoes

- 1. Homeowners raised concerns around mosquitoes being worse this year compared to prior years. Some homeowners shared that mosquitoes were about the same as prior years.
- 2. We discussed that mosquito abatement was removed from the budget this year due to lack of funds and not enough homeowners paying dues.
- 3. Some homeowners base their dues payments on mosquito abatement. Some only pay if mosquito abatement is provided and others won't pay because of it.
- 4. We will revisit this topic as we plan the budget for 2026.

B. New Camelot residents

- 1. Discussion on how we can identify new homeowners so we can share a welcome letter with information on the HOA.
- When new members ask to join the Facebook group, we can reach out to see if they're new to the neighborhood and use that as a mechanism to make contact.
- Another approach is to encourage neighbors to talk with the new homeowners and pass along information on the HOA so we can make contact.

- 1. A homeowner asked if there was an update on the directory.

- 3. We will follow-up on this in a future meeting to determine next steps.

D. Landscaping refresh for front entrance.
